Voter Registration and Election Information

Who may register? Any U.S. citizen who is a resident of the county and who is at least 17 years and 10 months of age.

When to register: At least 30 days prior to an election.

Where to register: applications are available at the County Treasurer's office, courthouse annexes, and county libraries.

Change of address: Correct the information on the reverse of the card, sign it, and mail it or take it in to the County Tax Assessor's Office.

Lost voter cards: Call the County Tax Office, 409-267-2746

Early voting: usually early voting begins at the county court-house 17 days before the elections; the annexes begin early voting about one week before elections; early voting ends 3
